#### **SESSION 1**

A brief introduction and update from Shane and Mike

### Introduction by Shane Gould, Head of Industrial Heritage Strategy, Historic England

Shane is the Head of Industrial Heritage Strategy within Historic England, which funds the Industrial Heritage Support Officer post.

This Network is one of 8 that are now up and running across the country in the following regions: London, North East, North West, Cornwall & Devon, South West, South East and West Midlands. Two other Networks are also planned in Yorkshire and East of England

### Dr Mike Nevell, Industrial Heritage Support Officer for England

The Industrial Heritage Support Officer post was established in 2012 to provide support and advice to the 600 Industrial Heritage preserved/protected sites that are open to the public in England.

Mike started his role in March 2020 and managed to visit a few sites before the COVID lockdowns began.

Of the 600 industrial heritage sites that are open to the public – approximately 350 are water & windmills and preserved railways. The mills tend to be run by volunteers and usually aren't part of larger museums. The railways are more business orientated and better at lobbying and raising money.

The remaining 250 sites include textile mills and mining sites, which are all listed or scheduled. They are sometimes part of larger organisations such as English Heritage and the National Trust. Some include larger individual sites such as Beamish and Ironbridge.

#### Challenges

In 2020 the Industrial Heritage sector has faced 2 major challenges:

- Climate Change (flooding) industrial buildings needing maintenance and changes made to adapt to climate/environmental issues such as erosion and degradation
- Covid-19 pandemic many industrial heritage sites rely on visitors and volunteers to survive. The two periods of lockdown in 2020 have seen annual visitor numbers reduce by more than 70% and increased vandalism found when some reopened.

When sites could reopen in the summer, 46 confirmed that they would remain closed until 2021. Many of the small volunteer sites are struggling to stay open. The long-term effect of the pandemic on volunteers is not yet known; there's a concern there might be less volunteers in the future.

Another concern is that Local Authorities may have to transfer assets as a way of reducing costs. This could lead to very few industrial heritage sites being managed by Local Authorities in the future.

#### **SESSION 2** The attendees each introduced themselves and the organisations they represented. They described the challenges they have faced this year • Have been opening only on a Sunday, but as from early August, will be **Neville Buckle** opening on Thursday's as well, although visitors can pre-book for times (Pleasley Pit outside of these days Trust) • A couple of the guides haven't come back but otherwise OK • Every 2<sup>nd</sup> Sunday in the month they run the electrical drive • Will be holding a Heritage weekend in September at Glenfield Tunnel but Chris with reduced numbers of guides as many of them have not come back. All Hossack tours are currently for a maximum of 10 people per tour instead of the (Leicestershire usual 25 Industrial • During the Archaeology Festival there have been tours of Swannington Heritage **Coal Mines** Society & • Although fewer in numbers, the teams have held up pretty well so far Glenfield Bulletins are regularly published, a recent one was about the Co-Op Tunnel) Movement in Leicestershire, they also publish a bi-yearly magazine for news • EMEAC has been suspended until "normal" times return • Opened on the 1st Sunday in July with 107 people visiting **Chris Page** • Have spent lockdowns completing maintenance, which was carried out by (Dogdyke volunteers and the good news is that they have a larger volunteer base for **Pumping** open days, which at the moment only occur on Sunday afternoons Station) • Have survived financially thanks in large part to receiving funding • Looking to do some promotion for more volunteers as they only have 3-4 currently • They did use the track and trace system but when they open up properly again this won't be continued, although they will keep sanitising points and social distancing in the smaller buildings • Very fortunate as they are not reliant on income from a single project **Peter Milner** • The 1st phase of Wingfield Station was the development phase and was (Derbyshire funded by the NLHF Historical • All planned public meetings were cancelled but everything else has been **Buildings Trust** successfully managed electronically & Wingfield • Have reined back the training and community engagement activities Station) • Eccles House had never previously had 100% occupancy until the pandemic as people started looking for more "out of the way" spaces • Have been investing in packages for larger audiences **Lucy Godfrey** • Have been creating their own films, including a series of mini films put (Wingfield together by a local film maker, that are now on the website Station) • Have been giving tours of the station whenever they can, these tours are free • Sudbury Gasworks – have received some NLHF funding for a community hub • Staff engagement had to be postponed for a key member of staff, but they have now come on board, starting in November 2020 • Frame Workers Knitters Museum has had some capital works finalised but have felt some impact with volunteers

David Knight	Haven't been able to meet in person but have quite a few projects on the go
Georgina Greaves (Derwent Valley Mills WHS)	<ul> <li>There are lots of new films online and some offline engagement of festivals</li> <li>The commercial shops at Masson Mills have closed</li> <li>Cromford Mills have received some Cultural Recovery Fund monies</li> <li>Have had lots of engagement with Schools but sadly the Victors Centre isn't open</li> <li>Strutts North Mill Museum has been flooded</li> <li>Have an older non-diverse volunteer demographic but they are working hard to change this</li> </ul>
Geoff Taylor (Chain Bridge Forge)	<ul> <li>Have done quite well during the pandemic as had funds coming from the local council and the Arts Council</li> <li>The museum has been closed but the working forge has remained open and has been exceptionally since July 2020</li> <li>They run taster sessions and created online capability 10 years ago as part of the local history resources, but they feel that they need to make more of this</li> <li>Have created an archive of the Flower Parade, with about 3500 items submitted by local people</li> <li>Have also created an oral history, which has been given to a local artist to create a visual representation of this</li> <li>Hoping to create a charity in order to promote local arts etc, although a bit of a standalone it is hoped it could work with IH sites to develop a "handover" to other sites</li> </ul>
Jason Morden (Notts CC Historic Buildings Conservation Officer)	<ul> <li>Have developed augmented and virtual reality resources</li> <li>Bestwood Colliery Winding Engine – doesn't make money and is run and managed by volunteers, they have only recently reopened, along with the Community Space nearby</li> <li>Jason is also the Chair of a charitable site (non IH), which has been funded by the NLHF</li> </ul>
Elaine Evans (Clipstone Colliery)	<ul> <li>After years of no investment etc the owner are now looking at the restoration of this site. It is currently closed to the public due to it being unsafe</li> <li>There is a market to be held nearby in a couple of weeks, which is hoped will encourage regeneration of the area</li> </ul>
